- 5 An eligible candidate can select the Supervisor from any of the affiliated colleges / institutions and the Co-supervisor may be selected from any where or abroad also, who is in service in any academic institution.
- 6 State Govt. reservation policy shall be applicable for each discipline /branch as per latest norms.
- 7 Last date for submission of the application at Research Centers is 16/08/2022.
- 8 Chairman, DRC will submit the branch wise final list of admitted candidates in the Ph.D.Programme to the University by 18/08/2022. Along with DRC recommendation report, Part B of application form and declaration form (if applicable) submitted by candidate.
- 9 The date of commencement of the course work in the Research Center is from 20/08/2022.
